Intrinsyc Signs Soleus License Agreement with GPS-E to Develop Connected Personal Navigation Devices

Soleus Transit enables OEMs to pick and choose the connectivity options requested most by their customers and integrates with Microsoft Visual Studio and Platform Builder for a powerful, easy to use solution. Designed to support navigation software incorporating connectivity solutions, Soleus Transit comes pre-integrated with Destinator which boasts industry-leading reliability and driving guidance. The simple, safe, and customizable UI provides users a number of viewing options, including day or night mode and 2D or 3D maps, while a powerful point-of-interest (POI) search is complemented by a growing selection of live content available from multiple sources.
